About Sana Kliniken AG

Sana Kliniken AG is a leading integrated healthcare provider in the DACH region. Its end-to-end healthcare solutions serve three million patients a year and extend from prevention through in- and outpatient care down to post-op and aftercare, rehabilitation and the supply of medicines and accessories.

These services are offered throughout Germany at 43 hospitals, 51 medical centers with almost 600 doctors' offices as well as some 60 medical supply stores and centers for preventative medicine.

Sana also offers B2B services and consulting for third-party clinics in areas such as purchasing, logistics, medical technology and management contracts. In 2023, it generated revenue of 3.3 billion euros with a workforce of approximately 38,600 employees. Sana Kliniken AG was established in 1976 and is owned by 24 private health insurers. All information is correct as of December 2023.

On 1 November 2024, Sana Kliniken AG acquired the Bavarian operations of the former Regiomed clinics.
